The Board further discussed the possibility of having the affected homeowners sign a document stating if they wish to have their fence reinstalled or not. This document will be presented at the special meeting to be held on October 26, 2015 at 6:00 p.m. One option is to have the District pay for the replacement of the fence on those lots where the homeowner has given their permission.

In the event the District proceeds with the removal of the fences and re-installation, Taylor Morrison has agreed to install a fence on the opposite side of the swale for any homeowners that wish to have a back fence installed. This will also be addressed at the special meeting on October 26th.

On a Motion by Mr. Basso, seconded by Ms. Mitchell, with all in favor the Board of Supervisors approved proceeding with the notification of the 44 affected residents and setting a special meeting to be held on October 26, 2015 at 6:00 p.m. for Channing Park Community Development District.
